Throughout 2025, Meadowlark Counseling Services remained committed to serving individuals and families across Tioga, Bradford, and Potter counties. We are credentialed with Medicaid, UPMC, Blue Cross Blue Shield (and affiliates), and CHIP, ensuring our services remain accessible and affordable to those who need them most. We also provide telehealth services, which has allowed us to expand our reach serving clients across the Commonwealth. Our dedication to inclusivity and affordability continues to guide every aspect of our operations.

### Commitment to Professional Excellence

Our team actively pursued opportunities to expand their knowledge and clinical skills by attending conferences such as the Joint Meeting on Youth Prevention Treatment and Recovery and the Penn State Addiction Conference, Clinical Supervisory Certification, and other relevant industry trainings. These experiences strengthened our clinical expertise and ensured we remain current with best practices in addiction treatment.

### Community Engagement & Prevention

In 2025, Meadowlark Counseling Services participated in numerous community events aimed at education, prevention, and connection. Highlights included:

- Continued to expand access to SUD counseling services in Knoxville, PA, improving availability for individuals in the "valley" region
- Relocation to a new Mansfield office at 267 South Main Street, offering more than double the space of our previous location and allowing for expanded services and enhanced client care

Our SUD counseling team also grew with the addition of two counselors, increasing our capacity to serve more individuals and families. Through responsible fiscal management and strong community support, Meadowlark experienced notable financial growth, positioning us to sustain and expand operations. The increasing number of individuals seeking our services reflects the trust our community places in our care.

## Valued Partnerships

None of this progress would have been possible without the support of our community partners.
